

CUSTOMS INFORMATION

IMPORT RESTRICTIONS FOR MEXICO

All shipments require a commercial invoice.

Commercial Value of goods an not exceed \$1,000 USD per shipment.

Shipping cost and Duties have to be prepaid (use the Mexican Commercial Invoice form to calculate the duties).

Shipments can't exceed maximum dimensions of 95"(L) x 41"(W) x 75"(H).

When shipping electronics, the commercial invoice needs to show the make, model and serial number

All shipments will be inspected, customers are required to deliver shipments in open boxes.
