Cargo Devices

Devices not listed in this Bulletin should not be accepted for shipment without the approval of the Director of Quality Control and the Director of Operations. If the device is not listed in the bulletin as approved, the shipper must provide the specifications to the Amerijet Cargo representative or Station Manager for transmission to Quality Control for review and approval or denial.

Shippers are required to advise Amerijet whenever tracking, recording and transmitting devices are contained in any cargo shipment.

Please refer to COM Chapter 2, Section 7, Paragraph I for the complete policy regarding Cargo Data Logging and Tracking Devices.
